PUBLIC OUTREACH AND STAKEHOLDER ENGAGEMENT

- 3 public open houses (in addition to regularly scheduled Police Jury and committee meetings)
- 2 public comment periods, 138 public comments
 - Submissions accepted via cppj.citizenreach.com, email, phone, and mail
- 18 stakeholder focus group working sessions
- Meetings with Mayors and City Council Representatives, Gravity Drainage Districts, GO Group Task Forces, and more
- Social media utilized throughout as mechanism for public education and soliciting feedback

KEY TAKEAWAYS

- Must work together to develop policies, ordinances, and capital project programming with a common mission in mind
- Must address both current and long-term needs through policies and projects
- Approach must be based on sound science and engineering, as well as public feedback
- Must be realistic about how to approach maintenance
- Must use existing funding wisely
- Effort must help sustain development, not hinder it

KEY CHANGES BASED ON FEEDBACK

- Detained storage volume was originally proposed to be at a 100-year storm event level but was changed to a 25-year level based on stakeholders' concerns about the severity of cost impact.
- We removed the prohibition of developing within the first 200 feet of the floodplain area.
- We moved from a singular policy focus to one that balances long-term policy changes with short-term projects (capital programming).



DRAINAGE POLICY FRAMEWORK

PROPOSED DRAINAGE DESIGN & CONSTRUCTION CRITERIA

- All new development activity must meet or exceed the following:
 - Maintain or lower existing water surface elevation profiles in receiving system
 - Protect and enhance flood storage volumes within the established 100-year floodplain
 - All new structures to follow minimum freeboard requirements

Policies and Ordinances

DEVELOPMENT

Standards for development and maintenance—parish and cities should be similar

ENFORCEMENT

Appropriate departments at Police Jury and cities; GDDs

Capital Improvement Program (CIP)

Police Jury takes lead role, solicits input from cities and drainage districts prior to program development

Functions as a three-year revolving program – updated annually – utilizing sound criteria for prioritization

CALCASIEU DRAINAGE COALITION

- Intended purpose is to serve a key role in consistent enforcement of polices and ordinances for development and maintenance ("the glue")
- As proposed, includes staff representatives from parish, cities, and Gravity Drainage Districts
 - Examples: public works directors, planners, superintendents, engineers, DOTD, and others as needed


CALCASIEU DRAINAGE COALITION

- Enforcement and accountability
 - Shorter Term: Meet frequently in short term to transition from policies to ordinances; as-needed afterward
 - Longer Term: Meet quarterly to discuss capital improvement programming and coordinate policy/ordinance enforcement
 - Following disasters and emergencies (including major rain events), coalition will meet to reassess project needs and other necessary changes

CAPITAL IMPROVEMENTS PROGRAM

- Development and maintenance of program
 - Police Jury takes lead role, solicits comprehensive input from cities and drainage districts prior to CIP development
- Utilizes sound criteria for prioritization (ensures allocations to smaller areas)
- Would be a three-year revolving program, updated annually

PROJECTS TO BE CONSIDERED ON A WATERSHED BASIS



COALITION NEXT STEPS

- Through Drainage Coalition, develop initial list of the top 10 projects on the priority list – determined through public feedback and prioritized through criteria framework
 - Spring 2017 (anticipated)
